Your board of directors has elected to set aside \$2,482,958.43 in excess margins for 2018. These margins—retained as patronage capital—will be used to help keep the cooperative financially sound and the quality of service as high as possible. The funds will also be used to retire debt and build equity in the co-op's distribution system. The board of directors will retire—or pay—those funds when the cooperative's financial condition permits.
