The election results were announced during the meeting. Members re-elected were Allyn Harms, Clarksville, and Gary Poppe, Nashua. Tom


Risse (pictured), Sumner, was elected to his first three-year term, filling the seat of Steve Boevers, Readlyn, who retired from the board after 12 years of service.

Grain bin requirements


When you start to plan for a new grain bin, please contact Butler County REC. We will provide assistance in planning for a safe environment for everyone working and living around grain bins. The State of Iowa requires specific clearances for electric lines around grain bins, with different standards for those filled by portable and permanent augers, conveyors, and elevators.

The drawings at the right show the specific clearances required for both scenarios. If you have any questions concerning the drawings, please contact Butler County REC or Corn Belt Power Cooperative.



According to the Iowa Electric Safety Code found in Iowa Administrative Code Chapter 199 -- 25.2(3) b. An electric utility may refuse to provide electric service to any grain bin built near an existing electric line which does not provide the clearances required by the American National Standards Institute (ANSI)C2-2017 "National Electrical Safety Code," Rule 234F. This paragraph "b" shall apply only to grain bins loaded by portable augers, conveyors or elevators and built after September 9, 1992, or to grain bins loaded by permanently installed augers, conveyors, or elevator systems installed after December 24, 1997. (The Iowa Utilities Board has adopted this language.)

COMPLAINT PROCEDURE

Effective May 22, 1991, the lowa Utilities Commission passed a ruling requiring all non-rate regulated utilities to post the following notice to its memberships: If a member-consumer has a question or concern regarding his/her electric service, please write or call your local electric cooperative at the following address or phone number:

Budget billing. When you sign up for budget billing, your energy bill is calculated by averaging your previous 12 months of use. With budget billing, your monthly energy costs are easier to budget and manage.

Home energy audit. Butler County REC's energy advisors are available to conduct a free energy audit of your home to identify areas where energy is wasted and provide recommendations on ways to improve efficiency and lower your monthly bills.

Rebate program. When you make upgrades or purchases to reduce home energy use, those smart decisions should be rewarded. We offer rebates on energy-efficient appliances, heating and cooling equipment, and more. Visit www.butlerrec.coop to learn about our rebate program.

You have the power. The best way to lower energy use during summer months is to raise the thermostat to the highest setting that's comfortable.
